



(21) The land to be enclosed with a kerb not to exceed 3 feet 6 inches for a single grave space nor more than seven feet for two spaces, so as to leave one foot between each enclosed space; the land to be measured in every case from the centre of the plot – the kerb in all cases to run with the level of the land.

The Committee also suggest that the fee for a coffin-shaped tomb over a grave shall be increased to £1-1s-0d and that the fee for interment of a non-parishioner shall be double the ordinary fee.
